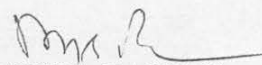

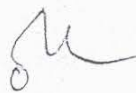

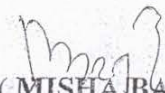
Subject:- Cancellation of membership of TAC on default of payment of bills.

2. It is also clarified that there is no bar to disconnect the TAC telephone if there is a dues. The disconnection due to non-payment of outstanding dues should not be delayed.



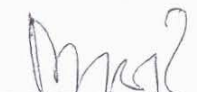

3. It is hereby clarified that **RESPECTIVE STATE** which an Hon'ble MP of Rajya Sabha represents, will be treated as his/her constituency.

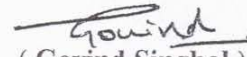
4. Similarly, constituency of nominated members of Lok Sabha and Rajya Sabha may be treated as **ENTIRE COUNTRY**.

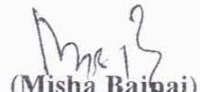
