VACANCY CIRCULAR

Subject: Filling up the post of Assistant Director (Official Language), Wireless Monitoring Organisation, (Headquarter), New Delhi, Department of Telecommunications in the pay level 10 of Pay Matrix (pre-revised pay scale PB-3 of Rs.15600-39100/- plus the Grade Pay of Rs.5400/-) on deputation (including short term contract) basis.

It is proposed to fill up one post of Assistant Director (OL), General Central Service, Group 'A', Gazetted, Non Ministerial in the level 10 of Pay Matrix (pre-revised pay scale PB-3 of Rs.15600-39100/- plus Grade Pay Rs.5400/-) in Wireless Monitoring Organisation, (Headquarter), New Delhi, a subordinate office of Department of Telecommunications on deputation (including short term contract) basis.

2. The eligibility criteria is as follows:-

Officers under the Central Government or State Governments or Union Territories or Public Sector Undertakings or Recognised Research Institutions or Universities or Semi Government or Statutory or Autonomous Organisation;

(a) (i) holding analogous posts on regular basis in the parent cadre or department; or

(ii) With three years' service in the grade rendered after appointment thereto on a regular basis in posts in Level 7 of Pay Matrix (Pre-revised PB-2, Rs.9300-34800/- plus Grade Pay of Rs.4600/-) or equivalent in the parent cadre or department; or

(iii) With eight years' service in the grade rendered after appointment thereto on a regular basis in post in Level 6 of Pay Matrix (Pre-revised PB-2, Rs.9300-34800 plus Grade Pay Rs.4200/-) or equivalent in the parent cadre or department; and

(b) Possessing the following educational qualifications and experience:

**Essential:**

(I) Master's degree of a recognized university in Hindi with English as a compulsory or elective subject or as the medium of examination at the degree level;

Or

Master's degree of a recognized university in English with Hindi as a compulsory or elective subject or as the medium of examination at the degree level;

Or

Master's degree of a recognised university in any subject other than Hindi or English, with Hindi medium and English as a compulsory or elective subject or as the medium of examination at the degree level;

Or

Master's degree of a recognized university in any subject other than Hindi or English, with English medium and Hindi as a compulsory or elective subject or as a medium of examination at the degree level;

Or

Master's degree of a recognised university in any subject other than Hindi or English, with Hindi and English as a compulsory or elective subjects or either of the two as a medium of examination and the other as a compulsory or elective subject at the degree level.

(II) Three years' experience of using or applying terminology (terminological work) in Hindi and translation work from English to Hindi or vice-versa, preferably of technical or scientific literature under the Central or State Governments or Autonomous Body or Statutory Organization or Public Sector undertakings or Universities or recognized Research or Educational Institutions; or three years' experience of teaching in Hindi and English or Research in Hindi or English under the Central or State Governments or Autonomous Body or Statutory Organisations or Public Sector Undertakings or Universities or recognized Research or Educational Institutions


### **Desirable**

Studied one of the languages other than Hindi included in the eighth Schedule of the Constitution at 10<sup>th</sup> level from a recognized Board.

Note 1: Period of deputation (including short-term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other Organization or department of the Central Government shall ordinarily not to exceed three years. The Maximum age limit for appointment by deputation (including short term contract) shall not be exceeding 56 years as on the closing date of receipt of applications.

Note 2: For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1<sup>st</sup> January, 2016 or the date from which the revised pay structure based on the Seventh Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay matrix extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit with extend only for the post for which that grade pay or pay matrix is the normal replacement grade without any upgradation.

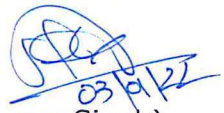
