CIRCULAR

Sub: Grant of Concessional Telephone facilities to retired DoT/Erstwhile P&T Department employees - regarding

In continuation to this office circular no. 2-79/94-PHA dated 25.09.1998 followed by clarifications issued vide circular nos. 2-79/94-PHA dated 30.12.1999 and circular no. 2-79/94-PHA dated 20.03.2009, it has now been decided by the competent authority to extend the facilities of concessional telephone connections to the retirees of erstwhile Posts & Telegraph (P&T) Department who had rendered 20 years or more continuous service in erstwhile P&T Department on or before 31.03.1985 i.e. before bifurcation of P&T Department and subsequently retired from Department of Posts.

2. The retired employees will have to furnish a service certificate for the service rendered in erstwhile P&T Department from the authority of the department/organization maintaining their service book and further they have to submit a copy of PPO issued by the Government to the service providers i.e BSNL/MTNL in order to get the concessional telephone facility under RE-DOT category.

3. All other terms and conditions laid down in DoT Circular no. 2-79/94-PHA dated 25.09.1998 followed by clarifications issued vide circular nos. 2-79/94-PHA dated 30.12.1999 and circular no. 2-79/94-PHA dated 20.03.2009 will remain the same.
